CITY OF HOLLYWOOD EMERGENCY ORDER 2020-06 REQUIRED PUBLIC USE OF FACIAL COVERINGS

As June 2020, the City of Hollywood is aware of confirmed cases of COVID-19 within its jurisdictional boundaries. To limit the potential community spread of COVID-19, it is now necessary for the City of Hollywood to continue to implement restrictions for the general health, safety, and welfare of the community. THEREFORE, pursuant to Section 252.38(3) and 252.46, Florida Statutes and Section 1.01 of the Charter of the City of Hollywood, as well as Section 40.01, City Code of the City of Hollywood, the City has the power to issue emergency orders with the force of law. The City Manager has expressly been authorized to issue Emergency Orders.

IT IS HEREBY ORDERED:

- 1. Purpose. The purpose of this Emergency Order is set forth in the recital clauses above and the recital clauses are incorporated and made a part of this Order.
- 2. Establishment of Required Use of Facial Coverings. Pursuant to CDC guidelines, all persons beyond the legal boundary of their residential property are required to wear a facial covering consistent with current CDC guidelines that cover the nose and mouth, including individuals within the common areas of all buildings with multiple residences and at their place of employment unless exempted by Emergency Orders issued by the Governor of the State of Florida or Broward County.

The following individuals shall be exempted from this order:

- A child under two years of age
- An individual who has one or more medical conditions or disabilities that prevent wearing a face covering
- An individual obtaining a service involving the nose or face for which temporary removal of the face covering is necessary to perform the service
- An individual who is employed in a profession where use of a face covering will not be compatible with the duties of the profession
- A person who is engaged in exercise activity such as walking, running, jogging, skating, bicycling, etc., while maintaining a six-foot distance from other individuals. If six feet is not possible, a facial covering must be worn.

TESTING FOR COVID-19


Two kinds of tests are available for COVID: <u>viral tests</u> and <u>antibody tests</u>.

- A viral test tells you if you have a current infection.
- An antibody test might tell you if you had a past infection. An antibody test might not show if you have a current infection because it can take 1–3 weeks after infection for your body to make antibodies. Having antibodies to the virus that causes COVID-19 might provide protection from getting infected with the virus again. If it does, we do not know how much protection the antibodies might provide or how long this protection might last.

If you test positive or negative for COVID-19 on a viral or an antibody test, you still should take preventive measures to protect yourself and others.

How to get tested for current COVID-19 infection

- To learn if you have a current infection, https://www.cdc.gov/coronavirus/2019-ncov/testing/diagnostic-testing.html are used. Most people have mild illness and can recover at home without medical care. Contact your health-care provider if your symptoms are getting worse or if you have questions.
- Decisions about testing are made by state and local health departments or healthcare providers. You can visit your <u>state</u> or <u>local</u> health department's website to look for the latest local information on testing.
- If you have symptoms of COVID-19 and are not tested, it is important to stay home. What to do if you are sick.

- 1 1/2 cups uncooked orzo pasta
- 2 (6 ounce) cans marinated artichoke hearts
- 1 tomato, seeded and chopped
- 1 cucumber, seeded and chopped
- 1 red onion, chopped
- 1 cup crumbled feta cheese
- 1 (2 ounce) can black olives, drained
- 1/4 cup chopped fresh parsley
- 1 tablespoon lemon juice
- 1/2 teaspoon dried oregano
- 1/2 teaspoon lemon pepper





- 1. Bring a large pot of lightly salted water to a boil. Add pasta and cook for 8 to 10 minutes or until al dente; drain. Drain artichoke hearts, reserving liquid.
- 2. In large bowl combine pasta, artichoke hearts, tomato, cucumber, onion, feta, olives, parsley, lemon juice, oregano and lemon pepper. Toss and chill for 1 hour in refrigerator.
- 3. Just before serving, drizzle reserved artichoke marinade over salad.
