Repairs and Improvements

- Two conference tables and 8 armchairs were assembled by our maintenance crew.

- Four metal kick doors were installed in the mezzanine garage.
- The round opening on the balcony ceiling of Unit #705 was filled.
- Eight exit doors were repaired.
- The 06 sanitation and air conditioning line were cleaned.
- The 03 air conditioning line was cleaned.
- The 07 riser was cleaned.
- The generator room was cleaned, and a first aid kit was installed in the room.
- The door sweep on the 4th floor was installed.
- New fluoresce ballast were installed.
- A new water faucet was installed in the Fiesta Room.
- Our maintenance personnel installed the Christmas lights on all three trees.

2020 Budget

The special membership meeting was held on Tuesday, December 10, 2019. This meeting was tabled because the necessary number of votes (127) to establish a quorum was not met to vote on full reserves or no reserves.

The board offered the owners the opportunity to reach a quorum by postponing the meeting by three additional days. When the meeting resumed on Friday, December 13, the number of votes needed to reach a quorum was still short of votes and a quorum was not established. Therefore, in accordance with Florida statutes 718.112(2)(f), Full Reserves were instituted for the 2020 Budget.

Management is in the process of mailing the 2020 maintenance coupons/statements. You should receive them by the end of the year. You will not be assessed late fees in January due to any delays you may have receiving your coupons/statements. If you have not received them by the end of the second week in January, please feel free to call Resident Services at 1-800-337-5850 and they will be able to email or mail you a copy.

As a reminder, maintenance fees are due on the 1st of each quarter; January, April, July, and October. Please be mindful that payments received after the 10th of the due date will incur late fees, and management automatically will assess your account with late charges except during January 2020.

Unit Owner (s) enrolled in the "AutoPay" Program will not receive a booklet. Quarterly maintenance payments will be automatically deducted from the registered financial institution.



Presupuesto 2020

La reunión especial de membresía se realizó el martes 10 de diciembre de 2019. En esta reunión no se alcanzó el número necesario de votos (127) para establecer un quórum para votar sobre reservas completas, o no reservas.

La junta ofreció a los propietarios la oportunidad de alcanzar un quórum posponiendo la reunión por tres días.

Cuando se reanudó la reunión el viernes 13 de diciembre, el número de votos necesarios para alcanzar el quórum aún no era suficiente y no se pudo llegar a un quórum. Por lo tanto, de acuerdo a los estatutos de la Florida 718.112 (2) (f), se instituyeron las Reservas Completas para el presupuesto 2020.

La gerencia está en el proceso de enviar por correo los cupones / estado de cuenta del mantenimiento de 2020. Estos deberán ser recibidos antes del fin de año. No se aplicarán cargos por tardanza debido a demora que pueda ocasionar al recibir sus cupones / estado de cuenta. Si no los ha recibido al final de la segunda semana de enero, no dude en llamar a Servicios para residentes al 1-800-337-5850 y podrán enviarle una copia por correo electrónico o por correo regular.

Como recordatorio, las tarifas de mantenimiento vencen el 1 de cada trimestre; enero, abril, julio y octubre. Tenga en cuenta que los pagos recibidos después del 10 de la fecha de vencimiento incurrirán en cargos por demora y la administración automáticamente le cargará tarifas por tardanza de pago, excepto el mes de enero de 2020.

Los propietarios que hacen sus pagos de modo automático "AutoPay" no recibirán cupones. Los pagos de mantenimiento trimestrales se deducirán automáticamente de la institución financiera registrada.
