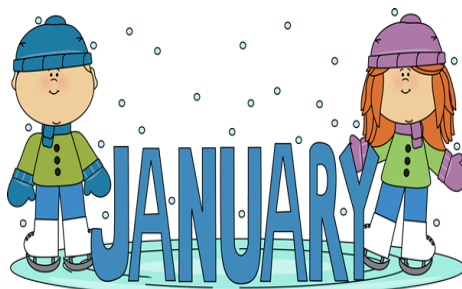

Available Storage

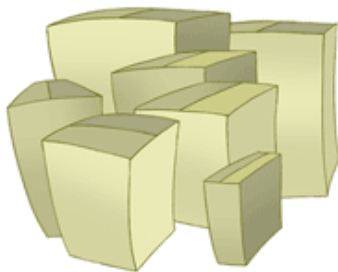
Storage units are now available for rent, please contact the Management Office for details.
