

BOARD OF DIRECTORS MEETING MINUTES

Thursday, September 09, 2021 Via Zoom - 7:30 P.M.

Board Members Present: Miguel Portu, Stephen Biondi, Cesar Dalmau, Karmenchu Santana, Joanna Gonzalez, Maria Iglesias and Fernando Blanco. Castle Group: Bryan Hoyos- LCAM-Property Manager

1) ESTABLISHED A QUORUM VIA ZOOM CONFERENCING: 7:31 pm.

2) APPROVAL OF MINUTES:

Maria Iglesias made a motion to approve the minutes of August 05, 2021. Fernando Blanco seconded the motion. The minutes were accepted unanimously.

3) **COMMITTEE REPORT**

Cesar Dalmau notified the membership of the Association is over \$50K under budget for the year. Cesar continued to inform the Board of the Bank confirming inactive Association accounts with funds to move into the operating account. Cesar notified the Board on the status of delinquent accounts making up about one percent of the membership. Cesar continued to inform the Board that he is exploring options to provide a monthly financial update report to the community.

4) RISK STRATEGIES PRESENTATION

Risk Strategies Vice President Kristie Gentile notified the Board of an updated property appraisal completed for the Association. The appraisal report states the Association is approximately \$2.5 million off from what the appraised value is. Kristie informed the Board the property & equipment break down policy annually is approximately \$17,800. Kristie continued by informing the Board of her recommendation to endorse the policy midterm and increase the property value.

Kristie notified the board the increase in policy will be on a pro rata bases until renewal in May of 2022. Kristie proceeded to remind the Board the hazard policy will cover up to the drywall; the floor coverings, cabinetry, countertops etc. is the responsibility of the unit owner. Kristie informed the Board capital improvement projects will increase the property value and decrease premiums in the future. Stephen Biondi motioned to have Kristie Gentile move forward with the endorsement of the new property appraisal. Karmenchu Santana seconded the motion. The motion was unanimously approved.

5) SOUTHERN COATING INC. PRESENTATION

Scott Biederman gave the Board of Directors a brief introduction of his company as well as an update of his inspection of the roof of the building. Scott continued to inform the membership of his proposal to complete the roofing project. A discussion ensued on the proposed scope of work. Scott notified the Board the lightweight concrete on the roof needs to be removed and scarify the concrete deck. Scott proceeded to inform the Board he is proposing to install a General Electric Roof with a negative 495 wind warranty.

Scott notified the Board of Directors if he is selected to complete the roofing project the Association will have the first two years free of maintenance. Scott informed the Board he projects a maintenance agreement will cost the Association approximately \$3,500.

6) APPROVAL OF MAIN LOBBY A/C REPAIRS

Management notified the Board of estimates received to replace the A/C unit servicing the main lobby and management office. Management continued to inform the Board on the condition of the two five-ton A/C units. Management requested Board approval to replace both five-ton units estimated at \$4,950 per unit.

Karmenchu Santana motioned to approve Navas Multiservice proposal to replace two five-ton units in the main lobby. Joanna Gonzalez seconded the motion. The motion was unanimously approved.

7) ADJOURNMENT

Stephen Biondi made a motion to adjourn meeting at 8:52 pm. Miguel Portu seconded the motion. The motion was unanimously approved.
