OWNER'S UPDATE OCTAGON TOWERS CONDOMINIUM



- The Annual meeting was scheduled on December 6th, 2023. As previously communicated, no election was needed. An organizational meeting took place to elect the Officers of the Board on December 13th, 2023, but one officer position is not determined yet. Information will be communicated as soon as possible.
- The work on the 19th St pedestrian exit door column has been mostly completed. Some touch up paint and adjustments are still needed.
- Suncoast Elevators is currently in the permitting process for the elevator's modernization. They should submit the permit application to the City of Miami Beach in the coming days since the proper paperwork has been signed by the association.
- The landscape company came back to treat the Ficus hedges against white fly. The hedges are growing back with small new leaves, but it will take time to fully recover from the infection.
- The city of Miami Beach has been contacted to verify the drain at the corner of 18th St and Washington Ave since it might be clogged. The drains on the parking lot were cleaned recently. We are still working on the sleeving project of all the pipes within the parking lot.
- The exit gate that was damaged during the last episode of storm was repaired and reinforced at the bottom by welding an additional bar.
- The lobby floors should be polished in the coming weeks. We are pending a date of completion from the contractor.
- The 2024 budget meeting will be held on December 28th, 2023, at 6pm. Notice has been mailed out, emailed and posted on the property.
- Please find below a reminder regarding trash disposal:
 - Refuse/bagged garbage shall be deposited only in the trash chute, or in the containers provided in the trash room. In this regard, all refuse must be in sealed bags. -Cardboard boxes or any size, wire hangers,

newspapers, and any item that might clog the chute must be brought to the ground floor trash room, which is accessible from the atrium. -No construction debris, paint cans or other volatile or inflammable objects shall be placed in the trash chute, recycling bins or trash room. These items must be properly disposed of in accordance with the environmental protection guidelines. BULK TRASH IS NOT ALLOWED IN THE BUILDING'S TRASH ROOM.

- o Please arrange for a pickup or dispose of your bulk trash with the city of Miami Beach, the information can be find here: https://www. miamibeachfl.gov/city-hall/public-works/ sanitation-division/bulk-disposal/
- o Recycle all glass, plastic containers and newspapers in order to keep our sanitation costs down. Recycling bins are in the trash room. -All household garbage must be placed in sealed plastic bags that can fit easily into the trash chute openings. RULES WILL BE STRICTLY ENFORCED.
- o The annual trash chute cleaning will take place on December 20th, 2023,

between 12:30pm and 5pm.

- The lobby floor polishing will take place on December 18th, 2023, at 9am. The work will take 2 to 3 days and traffic will redirected as needed.

Smoked Salmon Dip

Ingredients

- 1 (8 ounce) package cream cheese, softened
- 6 ounces smoked salmon, chopped
- ½ cup capers, or to taste
- 2 tablespoons chopped green onion (Optional)
- 1 ½ teaspoons chopped fresh dill
- ½ cup heavy whipping cream
- 3 dashes Worcestershire sauce
- 3 drops hot pepper sauce
- 1 squeeze fresh lemon juice

Directions

- Process cream cheese in a food processor to soften completely.
- Add smoked salmon, capers, green onion, dill, cream, Worcestershire sauce, hot pepper sauce, and lemon juice. Process the mixture again until creamy and smooth.
- Serve with crackers & vegetables.
