### **PROJECT UPDATES**

**Pool** - The pool is now open for use. The decision to remodel is still pending board approval but the Mirasol pool is swim ready for summer !

**50-year recertification-** The structural and electrical packets are complete. The BOD is now working with the construction committee to move forward in the process.

**Sprinklers**-Sprinklers have been installed in 20 hallways. Sprinklermatic has began on 5/7 with the Lobby and PH Floor.

**Parking Garages-** Parking garage cleaning will continue. Painting has also been done to the front drive way area.

**Fire Alarm -** The building conducted a mandatory annual fire alarm test from 4/8/2024 to 4/12/2024. We are now awaiting the completed report.

**Hallway** - NAFA has completed the hallway painting and will now move into making repairs and adjustments.

**Exit doors -** The Mirasol team has begun surveying the exit doors and examining conditions of the doors. Maintenance will begin making repairs to some doors while the board selects a contractor to replace the others.


**BDA-** BDA will begin their installation within August.

**Smoke Detectors –** Smoke detectors will be installed in all units starting 08/11/2024.



**Cooling Tower-** PSI has ordered parts and began repairs as of 05/29/2024. The repairs are still on-going.

**Windows-** The forensic testing report was received. Using the findings Mirasol will be bringing 3 contractors to perform the work on 3 separate line. At the end, once the jobs are complete and Mirasol confirms they are water tight, a contractor will be chosen.

# **CLEAN YOUR INDOOR AIR**

- Dust your home regularly and clean large flat surfaces several times a year.
- $\Box$  Vacuum and sweep regularly.
- □ Clean and change the filters on any humidifiers or air-filtration systems regularly.
- $\hfill\square$  Wash all bedding in hot water weekly.
- □ Use non-toxic cleaning products and don't mix different types of cleaning solutions together.
- $\hfill\square$  Place some houseplants in your home. They remove toxins from the air.
