I also release and waive any claim against the Association for (a) any failure for my electronic mail to deliver the Association's email(s); (b) any failure by myself to notify the Association of any change in my email address; or (c) any failure by myself to check periodically I also consent to the Association's publication of my e-mail address, as well as other information (including necessary personal identifying information) to electronic voting service providers or other third parties to the extent and as may be reasonably necessary to enable the use of electronic voting processes. Move-In and Move-Out **Procedures**

obtain Residents must authorization the from Association Condominium office at least 72 hours prior to moving in or out. This includes:

- Non-Refundable Elevator Protection Fee: \$100 per move-in or move-out. Elevators will be padded to prevent damage.
- Security Deposit: refundable deposit of \$500 (by physical check) is required before the move, which will be returned upon satisfactory completion.
- Delivery Supervision: All deliveries must be supervised by the resident to ensure property care. Any issues must be promptly reported before the delivery personnel leave.

Failure to comply may result in denied entry and additional charges.

FIGURE IT OUT

The first week in November is National Fig Week. Figs are not the most familiar of fruits, but they are a great addition to anyone's diet. Not only are they sweet and delicious, they are fat-free, high in fiber, and also a great source of potassium, calcium, and iron. Not sure how to use figs? These ideas and recipes will help get you started!

- Take figs in a plastic bag along with you to work, to school, to the game or the park for a quick snack.
- Slice up some figs and add to a tossed salad.
- Chop and add some figs to mashed or cubed sweet potatoes.
- Blend some finely chopped figs with some cream cheese to make a great spread for toast or bagels.
- Top your oatmeal or cold cereal with chopped figs.

Fig Pudding

1/4 cup butter 1/2 cup sugar 1 egg

1-1/2 cups sifted flour 2 cups chopped dried figs

teaspoons baking powder

2 teaspoons baking powder

1/4 teaspoon salt

1/2 cup milk

1/2 teaspoon vanilla



Cream the butter; add the sugar and the well-beaten egg. Take out about 2 tablespoons of the flour and mix with the figs. Sift together the remaining flour and the baking powder and salt and add alternately with the milk to the butter and egg mixture. Stir in the flour-coated figs and add the vanilla. Bake in a greased baking dish for about one hour in a moderate oven (350 degrees F.).

Serve hot with lemon sauce or hard sauce to which a little lemon juice has been added.
