

CORONADO 2025 BUDGET

Dear Unit Owners,

The Budget for fiscal year 2025 was approved by the Board of Directors at the Budget Adoption Meeting held on December 26, 2024. The new maintenance rates will be effective on January 1, 2025. (See schedule of payments below).

For owners who have set a **Fixed Payment Amount** in Click Pay even if it is automatic payment, please remember to update your payment amount to match the new maintenance fee. However, for owners who are enrolled in Full Amount automatic payments through Click Pay, please note that you do not need to take any action. The system will automatically update to reflect the new maintenance fee for 2025.

Unit Owners using any other method of payment like Check or BillPay through their bank, will have to change the amount on the maintenance payment starting on 01/01/2025 as follows:

Hot Spinach Artichoke Dip

- 1 (8 oz) package cream cheese, softened
- ¹/₄ cup mayonnaise
- ¹/₄ cup grated Parmesan cheese
- ¹/₄ cup grated Romano cheese
- 1 clove garlic, peeled and minced
- $\frac{1}{2}$ teaspoon dried basil
- ¹/₄ teaspoon garlic salt
- salt and pepper to taste
- 1 (14 oz) can artichoke hearts, drained and chopped
- $\frac{1}{2}$ cup frozen chopped spinach, thawed and drained
- ¹/₄ cup shredded mozzarella cheese

Gather all ingredients. Preheat the oven to 350 degrees. Lightly grease a small baking dish. Mix cream cheese, mayonnaise, Parmesan cheese, Romano cheese,



garlic, basil, garlic salt, salt, and pepper together in a medium bowl. Gently stir in artichoke hearts and spinach. Transfer the mixture to the prepared baking dish; top with mozzarella cheese. Bake in the preheated oven until bubbly and lightly browned, about 25 minutes.
